The B-Mortar system consists of two complementary components: **B-Mortar 1**, a repair mortar designed for aesthetic concrete repairs (cracks, cavities, etc.), and **B-Mortar 2**, a pigment (black or white) to be added to the mortar to adjust its shade to that of the surrounding concrete and thus minimize the visibility of the repair.

4. Mix mechanically until homogeneous.
